- The engagement is on Purely Temporary and contract basis. The engagement shall be initially for a period of one year and/or co-terminus with the projects, whichever is earlier. - 2. The extension of tenure of any Project Staff beyond the initial engagement will be subject to review and tenure of the Project.
- 3. The selection will be based on screening of the applications followed by personal interview.
- 4. Candidates will be shortlisted based on their applications by the screening committee. Candidates are required to clearly mention in the application the post/s for which they have applied. The candidates applying for more than one post must submit application for each post separately.
- 5. Shortlisted candidates will be called for the personal interview. The details of the interview will be **intimated by** e-mail only to the shortlisted candidates.
