If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information, their candidature may be cancelled at any stage, and the candidate will be liable to removal from service after joining at any stage, and such other action as may be deemed necessary, may be taken by the Competent Authority, CSIR-4PI.

SC/ST/OBC/EWS/ PwBD candidates must submit a valid certificate at the time of joining. Candidates who are already employed must submit NOC/duly-accepted relieving/resignation certificate from the present employer at the time of joining.

The Provisional offer of appointment to the selected candidates is being sent by Speed Post to the permanent address as given in their application form.
