Please provide the information for an RTI application received on 31-12-2018 from Mr Bharatashree, Udupi seeking information under the Right to Information Act, 2005 (attached herewith).

The requisite information should be sent so as to reach the undersigned on or before 16-01-2019.

It would be worthy to highlight hereunder the relevant provisions of the act u/s 5(4) and 5(5) that makes every person involved in the chain of processing of information under RTI Act, responsible for the delay or non-provision of information considered eligible under this Act.

The Central Public Information Officer/State Public Information Officer, as the case may be, seek the assistance of any other officer as he or she considers it necessary for the proper discharge of his or her duties.

Any officer, whose assistance has been sought under sub section (4), shall render all assistance to the Central Public Information Officer or State Public information Officer, as the case may be, seeking his or her assistance and for the purpose of any contravention of the provisions of this Act, such other officer shall be treated as a Central Public Information officer or State Public Information Officer, as the case may be.

Further, as per Sub Section (1) of Section 7 of RTI Act 2005, not furnishing information within the specified time shall attract a penalty of two hundred and fifty rupees each day till information is furnished, subject to a maximum of Rupees Twenty Five Thousand. As per the RTI act, any dispute with regard to the information provided, the information provider is held responsible for the same.
