- 6. VAT registration number should be mentioned in the bill, wherever VAT applicable. This Office is not eligible to issue C/D Form, but the concessional rate of Central Sales Tax admissible to research and educational institutions on purchase of scientific instruments/equipments etc., from certain states like Gujarat and Delhi is applicable to this office.
